**INSPECTIONS - Contractors shall call for these inspections as needed:**

POOL SITE - Contractors shall stake and string the pool area, nearest property line and utility easements.

GROUNDING & BONDING

FINAL INSPECTION - Final inspections will not be conducted until pool enclosure requirements are met.
