SUBMITTAL

A site plan drawn to scale (no smaller than 1"=20') to be submitted with the application must contain the location, size, height, construction material, color, type of illumination, and orientation of all proposed signs.

Please submit this completed application form with all required items, including ten (10) copies of the sign plan and site plan, to the Owasso [Planning Division](#). Applicants must submit a paper copy of all materials to Owasso City Hall **and** an electronic copy of all materials to planning@cityofowasso.com. Additionally, one (1) copy of construction plans is required at the time of submittal. Incomplete applications will not be accepted. Applications are due on or before the 1st of the month to be eligible for addition to that month's Technical Advisory Committee (TAC) meeting agenda. After TAC review, the application is included on the agendas for the next [Planning Commission](#) meeting. The applicant or the applicant's representative must attend the Technical Advisory Committee and Planning Commission meetings when their case is on the agenda.
